## 5) Market Condition

Every cuisine is a billion-dollar opportunity and may create 100 new start-ups in every state. Indian traditional foods are nutritious, tasty, and suitable to local climate and traditions. The market size of Indian traditional foods within India is Rs. 1300 million-plus global Market. For global markets, Indian traditional foods offer varieties to consumers always looking for new taste and options. Food is considered to be an inherent factor and a strong backbone of economic growth for any country. The market has significantly expanded primarily owing to the high demand among the large Indian population over the years. It is estimated that Indian Food Products revenue is expected to grow annually by CAGR of 8.01% (CAGR 2022 – 2027). The revenue is estimated to be largely driven by the increase in the disposable incomes and changing food habit of the people. There is a huge growth and demand for traditional food products due to Changing demographics, fast paced lifestyle, low work-life balance and changing consumption pattern has led to growth of lifestyle diseases in India, increase in awareness has led to people looking for prevention of these disease. People are increasingly looking for healthier alternatives in food to incorporate health in daily consumption. People realized the value of Indian traditional food products and started consuming Indian traditional food products.




